PUBLIC COMPLAINTS ABOUT LEARNING RESOURCES

It is the intent of the Board to provide a process whereby members of the community may call to the attention of the staff and the Board those educational materials that the individual or group deems objectionable. The Board will consider objections to educational materials only in the manner set forth in the administrative regulations found with policy INC.

An Albemarle County community member who has a concern about a learning resource will first discuss the concern with staff appropriate to the concern. As outlined in ACPS Board Policy INC, we expect students and parents to start by working with the teacher and /or principal or designee closest to the situation.

In the case of a community member who has a concern about a learning resource, it may be necessary to begin with the Superintendent or designee. After a conference with appropriate staff, if the Albemarle County community member requests the material be withdrawn from use, staff may honor the request if it is determined that such a decision is warranted. If the concern cannot be resolved, the process outlined in ACPS Board Policy INC for students and parents may be used for a community member as well to continue the complaint.
