STUDENTS WITH-INSUFFICIENT FUNDS FOR SCHOOL MEALS AND DELINQUENT SCHOOL MEAL ACCOUNTS

The National School Lunch and School Breakfast Programs are integral in ensuring that students have access to nutritious <u>school</u> meals to <u>support_fuel</u> their academic success. <u>The term "-school</u> <u>meal,"; is defined according to USDA Healthy, Hunger-free Kids Act of 2010.</u> It is also imperative <u>that the Albemarle County Public Schools ("ACPS")</u>to protect the financial stability of <u>its</u> school nutrition programs.

This policy address<u>e</u>²s the general process in handling student meal accounts, to includ<u>inge</u>;

- how to handle situationssituations in which when an Albemarle County student eligible for full- price or reduced-price meal benefits have insufficient funds to pay for school meals;
- > <u>nNnotificationying</u> and the collection of ing delinquent account debt; and the
- \blacktriangleright <u>s</u> school meal account refund process.

A meal charge is defined as a short-term loan <u>that will allow a student</u> for a customer to eat who does not have money in their account or in hand to cover the cost of the meal at the time of service to eat. This would apply to students of full price and reduced price meal status or employees with meal accounts. The school nutrition program is self-sustaining and relies on revenue generated from meals that are served. Therefore, charges must be kept to a minimum. School nutrition funds may not be used to offset meal charges. It is, ultimately, the responsibility of the parent/guardian of <u>the</u> student, and not the student's responsibility, to keep up-to-date of the status of the student's meal account. Student meal account status is available on the <u>Albemarle County Public SchoolsCounty's</u> Parent Portal, <u>the</u> online meal account systems, or by contacting the school cafeteria. The <u>p</u>Parent/<u>g</u>Cuardian is expected to keep their contact information current within the student information system at the school and to pay any charges that accrue_d-to <u>thea</u> student's account. County [ACPS employees or local govt?] employees with meal account status and make timely payments.

Students who come to the register with a reimbursable school meal and hashave insufficient funds to purchase a school meal, will be allowed to charge the school meal to their respective accounts. The term 'school meal', is defined according to USDA Healthy, Hunger-free Kids Act of 2010. However, Sstudents will not be allowed to charge a la carte (extra) food items or second meals. Students will never be made to work for their meals to settle any unpaid meal debt. In addition, students will not be labeled verbally or physically with a hand stamp, sticker, wristband, or identified in any other way if they cannot pay for a meal or have unpaid meal debt.

School employees with meal accounts may charge up to \$25 for food items. School employees are responsible for keeping up to date of their meal account balances <u>current</u> and paying any all charges in a timely manner.

<u>The Pparent/guardian is responsible for reconciling their child's meal account when withdrawing from Albemarle County School System the ACPS</u>. <u>Accounts with negative balances Negative accounts</u>_must be paid (at any school cafeteria). <u>The Pparent/guardian can request a refund for money remaining on the meal account by completing a prepayment refund request form which is available at all school cafeterias</u>. <u>After thirty (30)</u> days, unclaimed funds will become the property of the <u>Albemarle County Schools</u>, <u>ACPS</u> Child Nutrition Department.

The School Nutrition Program, through the use of a computerized school nutrition -accounting system, will allow and record charges, collect monies for payment of charges, and issue charge notices. Communications regarding meal debt will shall be directed to parents/guardians, rather than students. The School Board reserves the right to pursue appropriate action to collect funds of delinquent for collection of debt -unpaid meal charges.
