Mr. Alcaro, Chair, called the meeting to order at 6:30 p.m.

Ms. Schmitt, Ms. Kumazawa, Mr. Kirst, and Mrs. Castner provided for the Board's consideration information on the development of the School Board's budget. The presentation included information on enrollment projections, general growth, special education growth, and ESOL growth.

Mr. Alcaro asked if there was another presumption other than people moving in that would lead to the 105 percent in the Kindergarten enrollment.

Ms. Callsen asked if the County did any type of projections for population growth. Does the Division ever compare projections with the County?

Mr. Paige asked if staff worked with the Planning Commission on where things are being planned when making our projections.

Dr. Acuff asked if staff can see where the big increase in Kindergartners came from in the County.

Ms. Callsen asked if Weldon Cooper was still doing the projections for the Division.

Mr. Alcaro said that he could see where there would be variance in projections at the high schools because there are so many variables such as transfers from private schools.

Mr. Alcaro asked about the decrease in FTEs at Greer Elementary.

Ms. Callsen said that there is a reduction in special education costs due to the restructure, what is the restructure?

Mr. Paige said that on page B-18 under recovered costs for PREP in 2018-19 it shows \$42,000 but for this year it shows \$0. Why is it \$0?

Mr. Alcaro asked if Albemarle County was the only county starting to bring special education services inhouse in terms of the nine school divisions within PREP?

Mr. Alcaro asked what the WIDA test measures.

- Dr. Acuff asked how are high school ESOL students handled if there is limited English proficiency.
- Dr. Acuff asked if non-ESOL teachers receive any professional development in English Language Learners.
 - Dr. Acuff asked how students interact with the ESOL students.
- Mr. Alcaro said that the Building Bridges Through Bread program at CATEC is heavily attended by ESOL families.
 - Dr. Acuff asked if we are defining newcomers as English Language Learners only.
 - Ms. Callsen asked how we staff ESOL teachers at the Centers and the Academies.
- Ms. Callsen asked what salary the compensation was based on for the recommended 16 bus drivers being added.
 - Ms. Callsen asked for the per pupil expenditure per school.

Dr. Haas provided the Board with a copy of the Virginia Associations of School Superintendent's Blueprint for Achieving Equity.
