COVERAGE OF SCHOOLS DUE TO WEATHER AND/OR EMERGENCY

It is the intention of the <u>Albemarle County School</u> Board <u>("Board")</u> and its Superintendent/<u>d</u>Designee to provide staff coverage in all <u>school division <u>Albemarle County Public Schools</u> ("Division") buildings in order to maximize service to the citizens of the County. It is acknowledged, however, that there are times when coverage will be limited due to circumstances such as inclement weather or other emergency situations. In such instances, the Superintendent/<u>D</u>designee will strive to staff the <u>school division Division</u> buildings in order to provide necessary access by the public and to protect the safety of the employees and students.</u>

PROCEDURE FOR COMPLIANCE - COVERAGE OF SCHOOLS

- I. <u>General Coverage</u>. Principals<u>/ and department Department headsHeads/designees</u> are responsible for arranging coverage in their schools and departments to ensure the safe and effective operation of the Division. During periods of inclement weather or <u>in</u> emergency situations, certain staff <u>membersessential personnel</u> may be required to report for work or remain on duty.
- II. Liberal Leave. When conditions warrant, the Superintendent/designee may designate a liberal leave period when buildings are not closed Principals and department heads should allow staff to take unscheduled leave during due to emergency situations, such as inclement weather., During this period Principals/Department Heads/designees should allow staff to take unscheduled leave regardless of School Division closing or delay decisions, if their employees should feel it necessary. Employees may use applicable accrued leave without prior approval during liberal leave periods. Any employee who does not report at the designated time or leaves prior to employees being released, will have to account for missed work time, using leave or taking leave without pay in accordance with Albemarle County Public-Schools Leave Policy GCC and the Fair Labor Standards Act. When available, compensatory leave time and annual leave must be exhausted prior to sick/personal leave or leave without pay being used for this purpose. In lieu of taking leave, employees may be allowed to flex time with supervisor approval. Principals/Department Heads/designees- and department heads_also are responsible for monitoring time worked and leave taken to ensure employees are fairly and accurately compensated.

In the event If an essential personnel employee deemed essential personnel feels he/she is unable to report to work when required, the following guidelines apply. No leave would be charged if nonessential personnel in the same classification have been granted leave and only that amount of time is taken; leave or leave without pay would be taken otherwise, he/she must use applicable accrued leave or take leave without pay. These employees are not eligible for any paid administrative leave provided to non-essential employees for building closures. Essential personnel who are repeatedly unable to work during building closures may be counseled and/or disciplined as it is an expectation that essential personnel work during these situations when required by the supervisor. **H.**

- **III.** <u>Canceled Make-Up Days</u>. The <u>School</u> Board may <u>determine decide</u> that a specified number of missed days do not have to be made up by students and/or staff. Decisions to cancel make-up time for staff will be determined based on the number of days missed and the availability of work.
- IV. <u>Scheduled Leave</u>. Leave previously scheduled by an employee, which falls on a work-day when the employee's regular schedule is impacted by a delay, early closing, or closing, should be adjusted to account for the <u>delay</u>, early closing, or closingbuilding closure so that the employee <u>would areis</u> not be charged for the scheduled leave for such time.
- V. Impact to Work Schedule. All regular eEmployees are required to account for the number of workdays established for their positions unless the days have been excused by the Division. If the Division instructs an employee not to report for work due to a building closure, the employee will receive paid administrative leave up to his/her regular schedule for such time missed instead of having to use accrued leave or taking leave without pay. Inclement Paid administrative leave for building closures weatherleave is granted for safety reasons and is not intended as a right or employee benefit. Employees, whose regular schedules are not impacted by a the delay, early closing, or closureing, are will not receive notgranted additional leave or compensation. Because an employee's schedule may vary from that of a colleague, employees may receive different amounts of paid administrative leave for the same building elosure occurrence. However, if the employee is instructed by the Division not to report for work during periods of inclement weather or emergency, any regular employee whose scheduled is impacted willreceive paid leave time for such time missed if the time is not made up as a Division at a later date.

VI. <u>Working During Building ClosuresClosings.</u>. Non-exempt personnel will not receive additional compensation pay or time for time worked when not required to <u>_</u>report for work unless supervisor approval for the work has been gained in advance. This applies only to staff not expected to work during a closing. Essential personnel are expected to work during building closures. Such employees will not receive administrative leave for the work they perform during building closures. See Policy GCA for more information on essential personnel and Policy GCJ, Licensed and Classified Staff Schedules, Time Tracking, and Compensation for information on compensation during building closures.

VII. Key Terms:

- <u>A.</u> <u>12-Month Early Release</u> The Superintendent or designee determines that inclement weather or other emergency conditions warrant the early closing of school offices and departments and the early release of 12-Month employees, unless otherwise directed by the supervisor.
- B. 12-Month Do Not Report The Superintendent or designee determines that inclement weather or other emergency conditions warrant closing schools, school offices, and departments for the entire day; 12-Month employees should not report for work unless otherwise directed by the supervisor.

<u>2-Month Late Start</u> – The Superintendent or designee determines that inclement weather or other emergency conditions warrant a later opening for school offices and departments instead of the normal starting time; 12-Month employees will have a delayed starting time unless otherwise directed by the supervisor.

<u>2-Month Regular Schedule</u> – The Superintendent or designee determines that conditions warrant 12-Month staff to report as normally scheduled.

<u>G.</u> <u>Essential Personnel</u> <u>Certain personnel, as defined in their job descriptions (i.e. custodians and other Building Services personnel), may be required to report to their job sites during emergency situations, such as inclement weather. Supervisors should ensure that essential employees are aware of this fact and their appropriate reporting schedules for different situations. If an essential personnel employee is not required to report to work for the emergency, he or she should follow the reporting procedures for non essential personnel on that day unless otherwise directed by the supervisor.</u>

Non exempt essential personnel who report for emergency/inclement weather duty whenrequired will receive their regular rate of pay for the actual time worked. They will also receivestraight pay equal to the time granted for non-essential personnel in their matrix classifications. This time, on a daily basis, is not to exceed the employee's established regular number of hoursper day worked. Any time worked in excess of 40 hours per week will be paid in accordancewith the FLSA and County policy.

In the event an essential personnel employee feels he/she is unable to report to work when required, the following guidelines apply. No leave would be charged if non-essential personnel in the same classification have been granted leave and only that amount of time is taken; leave or leave without pay would be taken otherwise.

<u>atrix Classification</u> – For the purposes of this policy, this refers to the number of months an employee is assigned to work in his or her position. This will be 10, 11, or 12. Employees may seek clarification from their supervisors or <u>the Department of</u> Human Resources if unsure. The following matrix for inclement weather reporting is grouped by months worked, essential personnel, and self-sustaining programs.

- <u>LF. Make-up Day</u> Days when staff are required to report to work to make up for missed time.
- <u>LG. Make-up Time/Work</u> When <u>an employee misses</u> work <u>is missed</u> due to inclement weather or <u>Division</u>emergency situations, make-up work may be required and is to be performed during the week the work is missed, on a day when a school day is made up, on another day agreed upon by the supervisor, or at the end of the school year after students have finished classes. Contracted staff may be responsible for working the number of contracted days. Non-exempt staff may also be responsible for making- up any missed time. Any employee who does not make up any time required, must use <u>applicable accrued</u> leave time-or leave without pay.
- K.H. Schools For the purposes of this policy, "Schools" refers to student attendance in the school buildings.

GCQC-AP Page 4 <u>L.</u> <u>Schools Closed</u> – The Superintendent or designee determines that the inclement weather or other_

<u>I.</u> emergency conditions warrant the closing of the school for the entire school day. The missed day may be made up on a scheduled make-up day or, at the <u>School</u>-Board's discretion, the day may not be required to be made-up for students.

 $\underline{chools \ Early \ Closing}$ – The Superintendent or designee determines that inclement weather or other emergency conditions warrant the early closing of schools and releasing of students prior to the normal end of the day.

N.K. Schools Late Opening – The Superintendent or designee determines that inclement weather or other emergency conditions warrant a later opening time for schools instead of the normal start of the school day.

<u>O.L.</u> <u>Self-Sustaining Programs</u> – These programs generate the income necessary for their operation. Employees working for self-sustaining programs will follow the procedures as outlined in the Matrix. Supervisors should clearly communicate reporting procedures to employees, as they may vary depending on circumstances. Employees who miss time when required to work will be required <u>need-toshall</u> take <u>applicable</u> leave or leave without pay. Some self-sustaining program employees may be required to report for work on a regular or modified schedule when schools and/or departments are closed...

- VIII. Designated Building Closures. The Superintendent/designee will determine each period designated for building closures and may retroactively designate these periods.
- IX. Single Location Closures. In the event there is a situation only impacting certain buildings, such as power outages, the Superintendent/designee may limit closures to those locations. Employees whose locations are not impacted are required to report to work as scheduled. The Superintendent/designee may, but is not required to, designate a liberal leave period for employees working at other locations in these situations.
- **VIII.X.** <u>School Board Authority</u>. The Board <u>has reserves</u> the right to modify procedures and compensation practices outlined in this policy at any time <u>in accordance with applicable law</u>. Employees may be responsible for accounting for lost time, contrary to the matrix, at the Board's discretion.
- **IX.XI. Procedures.** In cases of inclement weather, the following matrix will be used for employees to determine work protocols and responsibility for make-up work. In the event of other emergency situations, the Superintendent/<u>or</u> designee may <u>give-issue</u> other reporting directions as deemed_appropriate.
