Superintendent Haas thanked Deputy Public Affairs & Strategic Communications Officer Jennifer Butler for her dedication and the long hours she invested in preparing the budget presentation for the evening's meeting.

Superintendent Haas addressed a recent public comment made during a public board meeting last month regarding teacher compensation in Albemarle County Public Schools (ACPS). The speaker claimed that a first-year teacher in ACPS earns "roughly \$60,000"--an amount said to be less than in Rockingham County, where the cost of living is lower.

Clarifications provided:

- ACPS's starting salary for a teacher on the bachelor's scale is nearly \$3,000 higher than Rockingham County's.
- Rockingham County does not offer a master's degree pay scale, so comparisons on that basis cannot be made.
- While Rockingham County has 42 steps on its teacher pay scale, ACPS has 32 steps.
 - o At step 32, ACPS's pay is \$15,050 higher than Rockingham's at the same point.
 - o ACPS's maximum bachelor's scale salary is \$3,867 higher than Rockingham's step 40.

Salary growth since FY20:

- Since Superintendent Haas's first budget in FY2019–20, ACPS has increased salaries by approximately 29% through compounded annual raises.
- In FY2021, there was no raise due to the pandemic, but that was addressed with two salary increases the following year.
- A staff member earning \$50,000 in FY20 would now earn approximately \$64,600, reflecting a gross increase of 26% and a compound increase of 29%.

Closing remarks:

The Superintendent emphasized the importance of fact-based public discussion, acknowledged Rockingham County as a strong and competitive district, and reaffirmed ACPS's commitment to monitoring compensation to remain competitive in attracting and retaining high-quality educators. The Superintendent encouraged the public to reach out directly for accurate and transparent information.

Board Member Comments – Community Tragedy in Crozet

- **Mr. Paige** addressed the recent shooting in Crozet, describing it as a tragedy affecting three families, including the family of the young man who committed the shooting.
 - He noted that the individual was a graduate of Western Albemarle High School and attended James Madison University.
 - The family had repeatedly sought mental health support and tried to invoke red flag laws to restrict his access to firearms but were unsuccessful.
 - Mr. Paige emphasized the need to improve mental health systems and red flag laws in Virginia and called for greater attention to families in crisis.
- **Dr. Acuff** thanked Mr. Paige for his remarks, calling them an important addition to the discussion.
- Ms. Spillman also thanked Mr. Paige and added a local perspective from Crozet.
 - She shared that Region Ten is meeting with her and other community members to assess mental health and trauma support needs.
 - o Region Ten has also offered to connect with ACPS staff to provide support where needed.

 She reassured the public that community efforts are underway to ensure people receive the help they need following the traumatic event.
