

Why now?

- Virginia Literacy Act is requiring changes to occur at the elementary and middle school levels to improve reading outcomes.
- Our goal is to partner with our families to make sure that we're moving every student towards being skilled readers and writers.
- We also want to show how evidence-based literacy instruction will positively impact our students' reading achievement at every level.

Literacy Plan: Purpose

- 1. Define and come to consensus on ACPS literacy beliefs that are grounded in research.
- 2. Define evidence-based literacy instruction at each level.
- 3. Define our tiered support systems.
- 4. Define how professional learning will improve student outcomes.
- Define how we will engage all families and our community to value and participate in the literacy development of all ACPS students.
- 6. Create a family-friendly literacy guide to distribute in August 2024.

Step 1

Researched Belief Statements We explored position statements from leading national organizations that represent the full literacy spectrum.

 We looked for commonalities in statements regarding the Science of Reading, equity, communication skills, and other lifelong learning outcomes.







Step 2

Surveyed literacy teachers across the Division to narrow beliefs.

 We surveyed over 100 Pre-K, elementary, and secondary ELA teachers.

 We collected open-ended responses from reading specialists and interventionists.

 The steering committee looked at all of the data and came to consensus on 7 beliefs.

Step 3

DLP Committee came to consensus on 7 beliefs.

We believe literacy development is strengthened through partnerships between schools, families, and communities.

We believe reading instruction includes explicit, systematic teaching of both word recognition and language comprehension.

We believe integrating reading, writing, research, communication, critical thinking, and collaboration in literacy instruction deepens student learning.

"WE BELIEVE LITERACY IS A HUMAN RIGHT"

We believe literacy is the act of constructing meaning from text. Literacy instruction is the responsibility of every educator across all content areas and all grade levels.

We believe the ultimate goal of literacy is to ensure that every student becomes an independent reader, writer, and communicator, and to explore and fully participate in a global society.

We believe that every student is entitled to receive evidence-based literacy instruction, opportunities, and resources.

Writing teams wrote 1st draft, received feedback and made revisions.


Step 5
